JSPS London call for the JSPS Pre/Postdoctoral Fellowship for
Research in Japan (Short-term)

Fellowship Start Period: 1st June 2027 – 31st March 2028

Closing Date for Applications: Monday, 9th November 2026 at 09:00 (UK time)

Award Information for Applicants

1. OUTLINE OF THE PROGRAMME:

This programme provides the opportunity for short-term visits for pre- and post-doctoral researchers based in the UK or Ireland and who are nationals or permanent residents from the UK, EU member states, Switzerland, Norway, the United States and Canada to conduct cooperative research with leading research groups at Japanese Universities and Institutions. The programme is designed to provide researchers with first-hand experience of the research and living environment in Japan, whilst expanding academic exchange between Japan and the UK or Ireland. Researchers from any fields; Computer, Engineering, Health, Biological, Life, Natural and Physical Sciences, Mathematics, Humanities and Social Sciences etc. are eligible to apply. Awards will cover visits of 1 to 12 months.

2. APPLICANT ELIGIBILITY:

- Applicants need to be based in the UK or Ireland for research purposes as of 1st April 2026.
- Postdoctoral candidates must have obtained their PhD at a university outside of Japan within the last 6 years (on or after 2nd April 2021), minus time taken off for maternity or paternity leave. Evidence of this leave must be provided with the application.
- PhD students must be enrolled in a doctoral course in the UK or Ireland and not Japan and be scheduled to receive their PhD within 2 years from the time of starting their tenure in Japan.
- PhD students undertaking formal distance learning PhD degrees and are based outside of the UK or Ireland are not eligible.
- Candidates who are expected to be conferred with their PhD before starting their fellowship must be able to submit a copy of their PhD certificate or letter confirming award of their PhD from their university/

research institute registration services before leaving for Japan.
Only nationals and permanent residents of the following countries are eligible to apply through JSPS London:

- **UK**
- **All European Member States (as of 1st April 2026) as well as Norway and Switzerland**
- **USA and Canada**

Nationals of other countries are eligible to apply to JSPS London if they have been engaged in PhD or Post Doctoral research continuously for a period of at least three years as of 1st April 2026 at a university or research institution in the UK or Ireland. These candidates must also come from a country with diplomatic relations with Japan or be from Taiwan or Palestine.

Nationals of other countries may also be eligible to apply for funding through JSPS Tokyo. In the case of applying to the JSPS Tokyo head office, the application must be made via the host researcher on the candidate's behalf. If you are in doubt about your eligibility status, please contact JSPS London to discuss.

NOTE:

- Candidates must, in advance of applying, have arranged a research plan with a host researcher in Japan and reached a point of agreement concerning any Intellectual Property considerations.
- It is JSPS policy to provide open access to research papers but it is not mandatory if there are justifiable reasons for deferral such as copyright related issues or insufficient repository infrastructure at the research institution. - Those who have previously been awarded another type of JSPS Postdoctoral Fellowship Programme for Research in Japan (Standard Postdoctoral Fellowship or Pathway to University Positions in Japan Postdoctoral Fellowship) are not eligible to apply.
- This Short Term Pre/Post-doctoral Fellowship is only awarded once to a single researcher.
- Those who have a residency card with a mailing address in Japan at the time of application are not eligible.
- Japanese citizens and those with permanent residency status in Japan or candidates of dual nationality including Japanese are not eligible to apply.
- Candidates who already have a residency card with a mailing address in Japan for the duration of the fiscal year this fellowship call covers are not eligible to apply.
- Overseas researchers doing research at a Japanese research institute at

the time of application are not eligible.

- Only one application per candidate is allowed in a call.
- The same person may not simultaneously apply for two or more types of JSPS Fellowship programme.
- Parallel applications for the same JSPS Fellowship programme through multiple overseas nominating authorities and/or with different host researchers in the same fiscal year is not allowed.

3. NUMBER OF GRANTS AWARDED:

Maximum of 20 awards per year.

- The number of awards indicated above are subject to change for budgetary reasons.

4. DURATION AND COMMENCEMENT OF AWARDS:

- Grants are awarded for a period of 1 to 12 months.
- The fellowship period starts from the day the Fellow arrives in Japan until the day of departure. (This does not apply to Fellows who reside in Japan before or after the Fellowship period).
- The Fellowship can not be divided into multiple stays.
- The duration must be for a full number of months.
- The closing date for applications is **Monday, 9th November 2026 at 09:00 (UK time)** and successful candidates can start their fellowships in Japan anytime between **1st June 2027 to 31st March 2028**.

5. JAPANESE HOST RESEARCHER AND INSTITUTION

JSPS does not find or introduce host researchers or institutions. It is the applicant's responsibility to contact a suitable Japanese host from the Japanese Universities and Institutions approved by JSPS. It is possible to search for a suitable host using the researchmap and JSPS-Net portals on the JSPS London website:

A host institution can be either a university or research institution as specified in Article 2 of the Procedure for the Handling of Grants-in-Aid for Scientific Research (KAKENHI), issued by the Ministry of Education, Culture, Sports, Science and Technology (MEXT).

Approved host institutions include:

- 1) Universities and inter-university research institutes
- 2) MEXT-affiliated institutions engaged in research
- 3) Colleges of Technology
- 4) Institutions designated by the Ministry of MEXT

If your preferred Host Institution is not included, please check the List of Eligible Host

Institutes provided by JSPS London in the list of documents for this call.

A host researcher must be an academic researcher who is employed full-time at a Japanese University or Institution acknowledged by JSPS. However, a researcher not employed full time may be eligible to be a host researcher if they are able to apply for KAKENHI (Grants-in-aid) funding and their institution judges them able to implement the project and provide an appropriate research environment. If in doubt about eligibility, please discuss with JSPS London before making an application.

The host researcher should also read the “Compliance Requirements for Host Institutions” document provided by JSPS and make sure they can agree to these conditions before deciding to take on this role.

NOTE: Full-time employment classification is determined by the regulations of the host institution.

A host researcher may not be changed during the fellowship tenure. At the time of application if it is known the host will retire during the proposed fellowship tenure, they should not be selected as a host at all.

An Invitation letter from the Host Institution must be provided in English and signed and dated by the host researcher to prove acceptance of your visit. The signature must be hand-written. A signature typed in a handwriting style font is not acceptable. Please use the sample invitation letter provided by JSPS London.

Evidence of correspondence with your host should be sent with your application in the form of e-mails and/or faxes and letters and should not be more than 10, A4 pages. The evidence should demonstrate the following:

- the host researcher in Japan accepts to provide for the research and welfare needs of the applicant and must be proactive in preventing any form of discrimination or misconduct on the part of the candidate during their tenure. If any such problems occur, the host should endeavour to resolve them.
- the project has been thoroughly discussed and developed with the host researcher.
- both the host and the applicant will benefit positively from the proposed collaboration.
- For research plans that include interviews, surveys, research or experiments which require prior consent from the research subject or or approval from an information-advisory or ethics committee either within or outside the Japanese host institution, the application should state the measures and actions that have or will be taken.

Please note, where e-mails or letters have been exchanged in Japanese, an English translation must be provided.

6. TERMS OF THE AWARD:

- JSPS' designated travel agent will provide a return air ticket for the most direct

and economical route.

- Monthly maintenance allowance of ¥362,000 (for Postdoctoral Fellows)
¥200,000 (for PhD Students)

*These rates will take effect according to the status of the applicant at the time their research in Japan starts. If a PhD certificate is submitted after the starting date of the fellowship, the amount of the monthly allowance will be increased for the first payment following a month after the date of submission of the documents to JSPS. However, the amount already paid will not be increased retroactively.

- Settling-in allowance of ¥200,000 (only for awardees with a tenure of three or more months).
- Overseas travel, accident and sickness insurance coverage (based on JSPS regulations).
- A research support allowance of ¥70,00 x number of months of tenure to cover cooperative research related expenses. The host researcher can apply for this allowance to the JSPS Tokyo head office once an award of a fellowship has been confirmed.
- The amounts of the award indicated above are subject to change for budgetary reasons.

NOTE:

- If the Awardee already resides in Japan or has residency status on or after the date his/her award letter is issued, the above mentioned air ticket to Japan and settling-in allowance will not be provided.
- A fellow may not engage in other work, paid or otherwise, during their tenure.

7. REPORTING OBLIGATIONS:

The awardee and their host researcher must submit a research report within one month of completing the fellowship tenure using a separately prescribed format.

8. DATA PROTECTION:

Applicants should be aware that all information provided will be dealt with in accordance with the UK General Data Protection Regulation and the Privacy Notice of JSPS London. Information will be held and processed at JSPS London, JSPS Tokyo and possibly other JSPS overseas offices and will be used exclusively for the implementation of JSPS programmes. Successful candidates should note that their name, nationality, title and affiliation, research theme, fellowship tenure, host institution, name and title of their host researcher and their research reports will be given public access. Host researchers and JSPS Fellows will also be asked to participate in surveys and questionnaires aimed at auditing and improving this fellowship programme.

9. CLOSING DATE FOR APPLICATIONS AND SUBMISSION:

The closing date for applications is **Monday, 9th November 2026 at 09:00 (UK time)**

Any applications received after the closing date or by post will not be accepted.

11. SELECTION CRITERIA

- Implementation of the fellowship contributes to promoting exchange between Japan and the UK.
- The collaboration can be expected to advance both the candidate's and host's research work.
- The host and candidate should have established contact in advance and created a concrete research plan.
- The host institution is expected to have adequately prepared a system for receiving the candidate.
- The research plan should show consideration to honing the research skills of the candidate.
- As much as possible balance should be achieved in the selection of candidates in terms of their nationality, host institution and areas of specialization.
- The grade and the reasons and comments made by the peer reviewer should be given adequate consideration for each application.
- One of two selection judgements for each application must be made: either (1) Selected or (2) Not-selected.

10. APPLICATION PROCEDURE, SELECTION AND NOTIFICATION

- On receipt of each application, peer review takes place with members of the JSPS London College of Reviewers based in the UK and Ireland.
- JSPS London recommends those candidates most highly evaluated to the JSPS Tokyo head office. JSPS London will notify all applicants of results by e mail, approximately 3 months after submitting the application.
- JSPS Tokyo will carry out necessary administrative procedures with the Japanese host institution and once complete will send a formal award letter and related documents to them. This process takes 4 to 5 months from the time of submitting the application. Please consider this time frame before agreeing on a Fellowship start date with your host.
- The names of the successful candidates, host researcher and their research theme will be posted on the JSPS Tokyo web site.

11. REFERENCES:

Two completed "References" must be sent by e mail from each referee to JSPS London by the closing date. JSPS London requests one of these references

comes from the institution the applicant currently belongs to and the other comes from preferably an external department or institution.

For PhD Students, one referee should be the applicant's supervisor and their reference should state the month and year in which the applicant is expected to receive his or her PhD.

The applicant's host researcher in Japan is **not** eligible to act as a referee for the application.

NOTE: Your choice of referee is a personal matter but JSPS London would advise that you choose someone who you feel is best able to give an informed opinion on your academic career, your proposed research project and the scholars involved, as well as to be able to assess its likely impact on the subject area.

Please note the following important administrative points regarding references:

Applicant's responsibilities:

- It is your responsibility to ensure that your referee obtains a copy of the **current** Reference Form and the Notes for Referees documents.
- **Without two valid references, the application will be considered incomplete and be withdrawn from the competition.**

12. RESUBMISSION POLICY

- **JSPS London currently operates an open resubmissions policy unless previous correspondence notifying results specifically does not invite this. An applicant is advised to obtain feedback from JSPS London before considering to apply again. A resubmission should take into account this feedback and be substantively different from a previous application with modified aims and objectives and revised methodological approach.**

13. OBLIGATIONS OF THE HOST RESEARCHER

The host researchers, their institution and candidate should keep in mind the following points in mind before applying and if selected all parties will be expected to observe the regulations and procedures stipulated in the Program Guidelines for the JSPS Postdoctoral Fellowship for Research in Japan. If either the candidate or host should fail to do so, the fellowship may be withdrawn, allowances (including airfares) stopped, and allowances already paid will be reclaimed.

- Before submitting an application, the host researcher shall fully inform the candidate of conditions at the host institution, including his/her status under the fellowship and the candidate needs to acknowledge and accept those conditions.
- The host researcher will, in cooperation with the administration office of the host institution, provide suitable arrangements for the fellow to pursue their joint research. The host will also assist the fellow, when needed, with immigration processing (including applying for a "certificate of eligibility"), securing domicile and other matters related to his/her stay in Japan.
- During fellowship tenures, the host should not commit acts of discrimination,

harassment or abuse towards the candidate and should be particularly careful their actions cannot be interpreted as committing such acts.

- During their tenure, a candidate must not infringe in any way on the human rights of others, including racial or gender discrimination or other forms of abuse.
- As a rule, the candidate should stay in Japan continuously during the tenure of their fellowship and concentrate on their research at the host institution. However, a candidate may suspend their fellowship for the purpose of childbearing or infant nursing, injury or illness.
- Any temporary absence must be approved by JSPS Tokyo in advance otherwise the Fellowship may be terminated.
- A fellow may not engage in other work, paid or otherwise, during their tenure. Only the following activities are allowable with prior approval from the host:
 - a.) Research related teaching to students at institutions
 - b.) Participating in a research project closely related to the applicant's research title
 - c.) Outreach projects relevant to the applicant's research title
 - d.) Events organised by JSPS for the applicant
- The host institution shall inform both the host researcher and applicant of their rules and those of JSPS to prevent research misconduct and misuse of research funds and penalties that will be enforced by the host institution for such violations.
- The host shall take full responsibility for the candidate's actions while in Japan, so must be proactive in preventing any discrimination, misconduct or misuse on the part of the candidate during their tenure. If any such problems should occur, the host should endeavor to resolve them.

14. NOTES

- Should JSPS London determine any information provided is incomplete, falsified, plagiarized or otherwise flawed, the application will be rejected, or if already awarded, the fellowship will be withdrawn, allowances (including airfares) stopped, and allowances already paid will be reclaimed.
- The candidate and host researcher must follow the rules established by the host institution and JSPS which prohibits acts of research misconduct e.g. fabricating and falsifying research results and misuse of funds. The host institution is responsible for explaining these rules and penalties for violations.
- Host institutions should establish educational courses for researchers to take in research ethics to promote the proper conduct of research activities.
- If the country you are travelling from has any travel restrictions to Japan please prepare your application to include specific plans for travel based on the best possible assumptions that can be made at the time of application.
- JSPS does not support any research project related to military affairs.
- Using generative AI when preparing an application risks unintentional infringement of copyrights and leaking of personal or confidential information. It is the applicant's responsibility to consider this risk when deciding whether to use generative AI.
- When accepting Fellows, the host institution should perform necessary procedures for the export and provision of technology concerning security trade control in accordance with the Foreign Exchange and Foreign Control Trade Law (Act No. 228 of December 1, 1949). JSPS Fellows must follow all of Japan's pertinent laws and ordinances, guidelines and directives in this regard.

- Host Institutions are also required to establish regulations/rules and control management related to the conflict of interest and the conflict of responsibility based on the “Policy on Measures to Ensure Research Integrity Against New Risks as a Consequence of the Globalization and Openness of Research Activities (April 27, 2021, Decision of the Council for Science, Technology and Innovation In Japan).” It is essential for researchers and host institutions proactively ensure the research integrity for every research activity undertaken.
- JSPS strictly enforces the United Nations Security Council Resolution 2321. Not limited to technologies restricted under Japan’s Foreign Exchange Law, Item 11 of this Resolution suspends all scientific and technical cooperation with North Korea with the exception of medical exchanges. Research organizations are required to bear the stipulations of this Resolution in mind when carrying out their various research activities.
- The host institutions that conduct animal experiments are required to comply with the “Basic Guidelines for Proper Conduct of Animal Experiments at Research Institutions” (Ministry of Education, Culture, Sports, Science and Technology Notification No. 71, 2006).
- Considering the situation of cases of tuberculosis in Japan, pre entry screening will apply to nationals of the Philippines, Viet Nam, Indonesia, Nepal, Myanmar and China.
- JSPS has established a policy on the basic principles of storage, management and publication of research data generated during research activities funded by grants provided by JSPS. Researchers funded by JSPS are required to comply to this policy as well as the regulations of their institution.
